**ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME**

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 12, 2000, Resthaven filed a motion with the Commission requesting permission to file its 1999 annual report out of time. Resthaven included its 1999 annual report with its motion. Resthaven stated in its motion that it attempted to file its annual report in a timely manner, but "[d]ue to unexplained postal delays, the Annual Report" was not received by the Commission until after the April 15 deadline. No objections to Resthaven's motion were received.

The Commission finds that good cause exists to permit filing of Resthaven's annual report out of time, and the Commission will grant Resthaven's motion for leave to file its annual report out of time.

**IT IS THEREFORE ORDERED:**

1. That Resthaven's June 12, 2000, motion requesting permission to file its annual report out of time is granted.

2. That the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of Resthaven's annual report on June 12, 2000, is approved.

3. That this order shall become effective on July 11, 2000.

4. That this case may be closed on July 12, 2000.

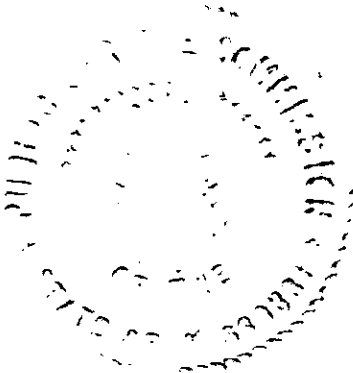
