ORDER REQUESTING SUPPLEMENT TO RECOMMENDATION

On March 27, 2000, Socket Internet Services Corporation (Socket) filed with the Missouri Public Service Commission (Commission) its application to cancel its certificate of service authority for competitive interexchange telecommunications which was granted on November 12, 1997, in case number TA-98-136.

On March 29, 2000, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation. Staff recommended that the Commission enter its order canceling Socket's certificate.

Socket made no mention in its application whether or not any of the annual reports required by Commission Rule 4 CSR 240-10.080 have been filed. Socket also made no mention in its application whether or not any of the annual assessments as required by Section 386.370, RSMo, have been paid.

The Commission will be aided in this case by Staff supplementing its recommendation with its conclusions regarding the status of the annual reports which Socket was obligated to file and also regarding the status of the annual assessments which Socket may have been



obligated to pay. Socket may also, if it so desires, file a response to this order.

IT IS THEREFORE ORDERED:

- 1. That the Staff of the Missouri Public Service Commission shall file a supplement to its recommendation no later than 3:00 p.m. on April 14, 2000, and that the supplement to its recommendation shall include the Staff's conclusions regarding the status of the annual reports which Socket Internet Services Corporation was obligated to file and also regarding the status of the annual assessments which Socket Internet Services Corporation may have been obligated to pay.
- 2. That Socket Internet Services Corporation may, if it so desires, file a response to this order no later than 3:00 p.m. on April 14, 2000.
 - 3. That this order shall become effective on April 14, 2000.
