**ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME**

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 15, 2000, Single Billing Services, Inc., d/b/a Asian American Association (AAA), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. AAA stated in its motion that it attempted to file its annual report in a timely manner, but "either because of delays in the United States Mail or because of inadvertent internal difficulties" the report was not received by the Commission until after the April 15 deadline. AAA also stated that the report was rejected because not all of the required financial information was included on the form provided. AAA indicated that it would need additional time to gather the necessary financial information and provide it to the Commission. No objections to AAA's motion were received.

The Commission finds that good cause exists to permit filing of AAA's annual report out of time, and the Commission will grant AAA's motion for leave to file its annual report out of time.

**IT IS THEREFORE ORDERED:**

1. That Single Billing Services, Inc., d/b/a Asian American Association's June 15, 2000, motion requesting permission to file its annual report out of time is granted.

2. That the annual report deadline requirement of 4 CSR 240-10.080 is waived and Single Billing Services, Inc., d/b/a Asian American Association, shall file its 1999 annual report no later than September 25, 2000.

3. That this order shall become effective on July 7, 2000.


