SECOND ORDER DIRECTING FILING

The Commission issued an Order Directing Filing on October 26, 1999, which directed GTE Midwest Incorporated (GTE) to file an answer or to file notice that the complaint has been satisfied. 1. That Complainant Gerry Miller, Presiding Commissioner of Barton County, shall file a response confirming or denying that the

complaint has been satisfactorily resolved, no later than November 30, 1999.

2. That this order shall become effective on November 24, 1999.
