#### ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

On May 18, 2000, Stone County Emergency Services filed a complaint with the Missouri Public Service Commission against GTE Midwest Incorporated (GTE) and Southwestern Bell Telephone Company (SWBT). On May 31, the Office of the Public Counsel (Public Counsel) filed a notice indicating that it intends to be an active participant in this complaint. On June 22, GTE and SWBT each filed answers to the Complaint.
