

ORDER GRANTING REQUEST TO EXTEND THE FILING DATE
FOR ANNUAL REPORT

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 5, 2000, Clearworld Communications Corporation (Clearworld) filed a request to extend the filing date for its 1999 annual report, along with a the annual report. Clearworld states that the annual report was mailed on April 14, 2000, as an officer of Clearworld erroneously believed that the postmark date would constitute the date of filing. Clearworld requests that the Commission grant an extension for the filing of the company's annual report.

The Commission finds that good cause exists to permit Clearworld to file its annual report out of time, and the Commission will grant the company's request to extend the filing date for the annual report.

IT IS THEREFORE ORDERED:

1. That the Request of Clearworld Communications Corporation to Extend the Filing Date for Its Annual Report, filed May 5, 2000, is granted. The annual report deadline requirement of 4 CSR 240-10.080 is waived, permitting the filing of Clearworld Communications Corporation's 1999 annual report on May 5, 2000.
2. That this order shall become effective on June 13, 2000.
3. That this case may be closed on June 14, 2000.
