

ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 15, 2000, Pae Tec Communications, Inc. ("Pae Tec"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. Pae Tec stated that it was unable to file its report timely due to inadvertent difficulties meeting the filing time. No objections to Pae Tec's motion were received.

The Commission finds that good cause exists to permit filing of Pae Tec's annual report out of time, and the Commission will grant Pae Tec's motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That Pae Tec Communications, Inc.'s May 15, 2000, motion requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of Pae Tec Communications, Inc.'s, annual report on May 15, 2000, is approved.

2. That this order shall become effective on June 2, 2000.

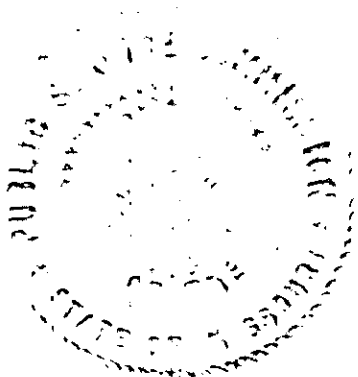
