ORDER GRANTING MOTION FOR LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 5, 2000, Affinity Corporation (Affinity) filed a Motion for Leave to File Annual Report Out of Time, requesting that its 1999 annual report, which was filed along with its motion, be accepted for filing out of time. Affinity states that it was inadvertently late in assembling the data for its annual report. - 3. That this case may be closed on June 26, 2000.
