ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 23, 2000, BroadSpan Communications, Inc., d/b/a Primary Network Communications, Inc. ("PNC"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. PNC stated that it was unable to file its report timely due to inadvertent difficulties gathering the information necessary and meeting the filing time. No objections to PNC's motion were received.

The Commission finds that good cause exists to permit filing of PNC's annual report out of time, and the Commission will grant PNC's motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That the June 23, 2000, motion of BroadSpan Communications, Inc., d/b/a Primary Network Communications, Inc., requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived, and the filing of the

annual report of BroadSpan Communications, Inc., d/b/a Primary Network Communications, Inc., on June 23, 2000, is approved.

- 2. That this order shall become effective on July 13, 2000.
- 3. That this case may be closed on July 14, 2000.
