ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE SURREBUTTAL TESTIMONY

On March 13, 2000, the Commission granted a Motion for Extension of Time to File Surrebuttal Testimony filed by Atmos Energy Corporation (Atmos) and Arkansas Western Gas Company, d/b/a Associated Natural Gas Company (ANG). That order granted Atmos and ANG's request that the procedural schedule be modified to make surrebuttal testimony due on March 22, rather than March 15. Atmos and ANG requested the additional time to allow the parties to further pursue settlement discussions.

On March 20, Atmos and ANG filed a second Motion for Extension of Time to File Surrebuttal Testimony. This motion again indicates that the parties are pursuing settlement negotiations and asks that the date established for the filing of surrebuttal testimony and the list of issues be put off until March 29. The motion also suggests that position statements by the parties be filed no later than April 3. The motion states that the other parties have indicated that they do not oppose this request.

The Commission has considered Amos and ANG's motion and concludes that continued settlement negotiations should be encouraged. Therefore, the request to extend the time for filing surrebuttal testimony and the list of issues will be granted. However, the parties are warned that this delay may necessitate a similar delay in the currently scheduled hearing dates, as the filing of position statements on April 3 would not allow the Commission sufficient time to properly prepare for a hearing on April 4 and 5.

IT IS THEREFORE ORDERED:

- 1. That the Motion for Extension of Time to File Surrebuttal Testimony is granted.
- 2. That Surrebuttal Testimony shall be filed by all parties on March 29, 2000, by 3:00 p.m.
- 3. That the List of Issues shall be filed by Staff on March 29, 2000, by 3:00 p.m.
- 4. That Statements of Position shall be filed by all parties on April 3, 2000, by 3:00 p.m.

5. That this order shall become effective on March 29, 2000.
