ORDER DIRECTING FILING

The internal reorganization which is the subject of this matter was approved on May 11, 1999. Thereafter, on October 26, 1999, the Commission approved certain tariff revisions whereby Primus Telecommunications, Inc., added the rates, services and regulations of TresCom USA, Inc., to its own tariffs. This action was intended to make the reorganization "seamless" as to TresCom's Missouri customers. The case was left open pending notification by the parties that the reorganization was finally complete. At that time, the Commission would cancel the tariffs of TresCom USA, Inc., and close this case. However, that notification has never been received.

IT IS THEREFORE ORDERED:

1. That Primus Telecommunications, Inc., shall file, on or before December 31, 2000, a status report with respect to the final completion of the reorganization and other transactions contemplated in this case.

2. That this Order shall become effective on December 17, 2000.
