MOTION TO REVISE PROCEDURAL SCHEDULE

Comes now Aquila, Inc., d/b/a Aquila Networks - MPS and Aquila Networks - L&P ("Aquila" or "Company"), and, as its Motion To Revise Procedural Schedule, states as follows to the Missouri Public Service Commission ("Commission"):

- 1. The Commission's Order adopting procedural schedule directs that the parties file the List of Issues, Order of Witnesses and Order of Cross-Examination ("List of Issues") on February 2, 2004. Aquila believes that the identification of this date for the List of Issues in the parties' original proposal was an over site by the parties.
- 2. The formal List of Issues would more commonly be filed by the parties at least after the filing of rebuttal testimony, as issues sometimes narrow during the filing of testimony. Additionally, the parties will have a better idea as to what witnesses will be testifying after the filing of rebuttal testimony. The current procedural schedule does not call for the parties' statements of position until March 16, 2004, a full six weeks after the List of Issues.
- 3. Accordingly, Aquila moves the Commission to revise the procedural schedule such that the List of Issues will be due on March 9, 2004, a week before the statements of position.
- 4. Counsel for all other parties (the Commission Staff, Office of the Public Counsel, Sedalia Industrial Energy Users, Department of Natural Resources, Cornerstone Energy and the City

of Kansas City) have indicated that they have no objection to this motion.

Wherefore Aquila respectfully requests that the Commission revise the procedural schedule such that the List of Issues, Order of Witness and Order of Cross will be due on March 9, 2004.
