

ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On April 28, 2000, J D Services, Inc. ("J D"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. J D stated that it was unable to file its report timely due to an inadvertent mistake regarding the filing time. No objections to J D's motion were received.

The Commission finds that good cause exists to permit filing of J D's annual report out of time, and the Commission will grant J D's motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That J D Services, Inc.'s April 28, 2000, motion requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of J D Services, Inc.'s annual report on April 28, 2000, is approved.

2. That this order shall become effective on May 23, 2000.

3. That this case may be closed on May 24, 2000.
