# ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION DECISION

On March 20, 2001, the Commission granted an extension of the variance from rule 4 CSR 240-10.030(19) for Atmos Energy Corporation, successor of Associated Natural Gas Company, a division of Arkansas Western Gas Company. On April 19, 2001, Atmos filed the proposed tariff sheet with the Commission in compliance with the Commission's March 20, 2001 order. On April 25, 2001, Atmos filed a substitute tariff sheet to correct a clerical error.
