#### **ORDER GRANTING EXTENSION OF TIME**

On January 16, 2001, AT&T Communications of the Southwest, Inc. (AT&T), filed a Motion for Extension, requesting an extension from January 22, 2001, to January 29, 2001, to file proposed findings of fact and conclusions of law. AT&T noted that no party objected to the request for an extension. The Commission issued an order granting the extension of time on January 18, 2001. On January 19, 2001, Southwestern Bell Telephone Company (SWBT), filed a Motion for Clarification, indicating that the parties intended the extension to apply to all the parties.

The Commission has reviewed the Motion for Clarification and the Motion for Extension and finds that the deadline for all parties to file proposed findings of fact and conclusions of law should be extended from January 22, 2000, to January 29, 2001.

#### IT IS THEREFORE ORDERED:

1. That the Motion for Clarification, filed on January 19, 2001, by Southwestern Bell Telephone Company, is granted. The deadline



for all parties to file proposed findings of fact and conclusions of law is now January 29, 2001.

2. That this order shall become effective on January 26, 2001.
