#### ORDER SETTING A PREHEARING CONFERENCE AND DIRECTING FILING OF PROCEDURAL SCHEDULE

On April 28, 2000, the Commission issued an order suspending a proposed tariff filed by Warren County Water and Sewer Company. The Commission acted in response to a Joint Motion to Suspend Tariff filed by the Staff of the Public Service Commission and the Office of the Public Counsel. In its order suspending the tariff, the Commission directed that a copy of the order be sent to the county government of Warren County, Missouri, the Board of Trustees of Incline Village, the members of the general assembly who represent Warren County and the newspapers that serve that county. The order directed that any person or entity wishing to intervene in this case should submit an application to intervene on or before May 18, 2000. No applications to intervene were submitted.

So that this case may proceed expeditiously, the parties will be directed to file a proposed procedural schedule. The procedural schedule shall include dates for the filing of testimony and for a hearing. To assist in the development of the procedural schedule and to clarify the issues in dispute, an early prehearing conference will be scheduled.



#### IT IS THEREFORE ORDERED:

- 1. That an early prehearing conference shall be held on June 7, 2000, beginning at 10:00 a.m. The prehearing conference shall be held at the Commission's offices on the fifth floor of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri. Anyone wishing to attend who has special needs as addressed by the Americans with Disabilities Act should contact the Missouri Public Service Commission at least ten (10) days before the prehearing conference at: Consumer Services Hotline 1-800-392-4211 or TDD Hotline 1-800-829-7541.
- 2. That the parties shall file a proposed procedural schedule no later than June 14, 2000. The procedural schedule shall include dates for the filing of testimony and for a hearing.
  - 3. That this order shall become effective on June 5, 2000.
