**RESPONSE OF CENTRAL JEFFERSON COUNTY UTILITIES, INC.
TO FILING OF MR. JOHN KOLISCH**

Comes now Central Jefferson County Utilities, Inc. (Company), and for its Response to the Filing of Mr. John Kolisch, states to the Missouri Public Service Commission (Commission) as follows:

1. On December 22, 2006, the Commission issued its Order directing Mr. Kolisch to file a document delineating the specific lots subject to connection fees related to his contribution of water and sewer lines and identifying which connections were at issue with those lots, i.e. water, sewer or both.


2. On December 27, 2006, Mr. Kolisch filed with the Commission several maps, which attempted to depict relevant parts of the Raintree Subdivision development and the extensions of water and sewer lines which were funded by Mr. Kolisch in accordance with the terms and conditions of the Company's water and sewer tariffs. It does not appear that Mr. Kolisch specifically delineated the lots subject to paying him connection fees pursuant to the Company's tariff.

3. Company has had an opportunity to talk with Mr. Kolisch and identify the lots which would be served by the water and sewer line extensions and which would therefore be required to make pro-rata payments (i.e. connection fees) to Mr. Kolisch at the time they connect to the water and/or sewer system, in accordance with the terms and conditions of the Company's tariffs.

4. The lots which would be required to make pro rata payments to Mr. Kolisch for connection to the water system are Lot Nos. 126 through 137 of Section 5 (a total of twelve (12) lots). The lots which would be required to make pro rata payments to Mr. Kolisch for connection to the sewer system are Lot Nos. 129 through 134 of Section 5 and Lot Nos. 46, 47 and 49 of Section 1 (a total of nine (9) lots).

5. Finally, the Company understands that Raintree Plantation, Inc. (the Developer of Raintree Plantation Subdivision) and the Jefferson County Public Sewer District remain willing to revise and amend their Sewer and Water Service Fee Agreement (Exhibit #8), regarding the "Payment to John Kolisch" so as to put Mr. Kolisch in the same position after the transfer of the water and sewer system to the District as he currently is in with the Company. This revision and amendment could be filed with the Commission prior to the closing of the transfer.
