## MOTION TO CONSOLIDATE

COMES NOW Confluence Rivers Utility Operating Company, Inc. ("Confluence Rivers"), and, as its Motion to Consolidate, states as follows to the Missouri Public Service Commission (Commission):

- 1. On November 2, 2017, Confluence Rivers filed an Application and Motion for Waiver for Confluence Rivers to acquire certain water and sewer assets of various water and sewer systems, along with a certificate of convenience and necessity. Two case numbers resulted from these filings (WM-2018-0116 and SM-2018-0117).
- 2. It is proposed that all of the relevant water and sewer systems will be purchased by Confluence Rivers. Several of the sellers have both water and sewer systems.
- 3. There are common questions of law and fact in the above-referenced cases and the consolidation of Files Nos. WM-2018-0116 and SM-2018-0117 would be administratively expedient in that it would simplify the filings to be made by Confluence Rivers and the other parties to these matters.
- 4. Commission Rule "4 CSR 240-2.110(3) allows the Commission to consolidate pending actions involving related questions of law or fact." Order Consolidating Cases, *In the*
