#### ORDER RECOGNIZING CHANGE OF NAME AND APPROVING TARIFFS

Intercontinental Communications Group, Inc. d/b/a Fusion Telecom (Fusion), formerly known as Intercontinental Communications Group, Inc. d/b/a ICLD, filed replacement tariffs designed to reflect the change of the company's fictitious name and modify the rates and rate structure of the company's existing service offerings. Fusion included with its filing a registration of fictitious name filed with the Missouri Secretary of State's office on May 4, 1999.

The Staff of the Missouri Public Service Commission (Staff) filed a memorandum on September 15 stating that it had reviewed the company's filing and proposed replacement tariff. Staff stated that on September 13, Fusion submitted substitute tariff sheets to reflect corrections to the title of the tariff from P.S.C. Mo. No. 2 to P.S.C. Mo. No. 1 and to clarify its list of Commission approved waivers. Staff also stated that the proposed tariff effective date was extended to September 27. Staff stated that it had no objections to the proposed tariff, as amended, and recommended that the Commission issue an order approving the corporate

change of name and approving the tariff to become effective on September 27, 1999.

Staff also stated that Fusion's proposed tariff reflects the change of fictitious name from ICLD to Fusion Telecom on each page, introduces a public telephone surcharge of \$.35, to recover the company's expense to comply with the FCC's pay telephone compensation plan, restructures the company's entire product offerings from rate plans offering mileage and time of day sensitive plans to flat rate calling plans and services, and introduces variations and calling options to existing services.

The Commission has reviewed Fusion's filing and finds that the name change should be recognized. The Commission further finds that the replacement tariffs, as amended, should be approved and shall become effective on September 27, 1999.

#### IT IS THEREFORE ORDERED:

- 1. That the fictitious name "Intercontinental Communications Group, Inc. d/b/a Fusion Telecom" is acknowledged.
- 2. That tariff file No. 200000142, submitted in Case No. TO-2000-177 by Intercontinental Communications Group, Inc. d/b/a Fusion, is hereby approved for service to be rendered on or after September 27, 1999.
