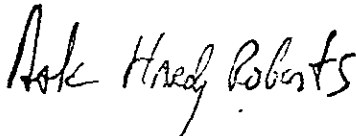

ORDER GRANTING REQUEST TO LATE-FILE 1999 ANNUAL REPORT

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 5, 2000, Kataman Communications, L.L.C. (Kataman), filed a request to late-file its 1999 annual report. Kataman indicates that its accounting firm was delayed in providing Kataman with necessary information. In addition, Kataman believed that since April 15, 2000, fell on a weekend, a filing postmarked on the next business day would be in compliance with the filing requirement.

The Commission finds that good cause exists to permit Kataman to file its annual report out of time, and the Commission will grant the company's request to extend the filing date for the annual report.

IT IS THEREFORE ORDERED:

1. That the Motion of Kataman Communications, L.L.C., to Late File Its 1999 Annual Report, filed May 5, 2000, is granted. The annual report deadline requirement of 4 CSR 240-10.080 is waived, and Kataman Communications, L.L.C., is directed to file its 1999 annual report no later than June 13, 2000.
