### ORDER GRANTING MOTION TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 10, 2000, Stouffer Communications, Inc. (Stouffer Communications), filed a Motion for Leave to File Annual Report Out of Time, along with the annual report form, requesting that its 1999 annual report be accepted for filing out of time. Stouffer Communications states that since April 15 fell on a Saturday this year, its accountant erroneously assumed that the date for filing the annual report would be extended to the next business day, which was Monday, April 17. Stouffer Communications mailed its annual report on April 17. However, the report was returned as not being timely and because all of the information was not on the Commission's form. Stouffer Communications states that it has now transferred the information to the Commission's form, and requests leave to file the annual report after the deadline.

The Commission finds that good cause exists to permit Stouffer Communications to file its annual report out of time, and the



Commission will grant the company's Motion for Leave to File Annual Report Out of Time.

#### IT IS THEREFORE ORDERED:

- 1. That the Motion for Leave to File Annual Report Out of Time, filed May 10, 2000, by Stouffer Communications, Inc., is granted. The annual report deadline requirement of 4 CSR 240-10.080 is waived, permitting the late filing of Stouffer Communications, Inc.'s annual report.
  - 2. That this order shall become effective on June 13, 2000.
  - 3. That this case may be closed on June 14, 2000.
