#### ORDER APPROVING INTERIM RATES

Missouri Public Service (MPS or Company) of Kansas City, Missouri, submitted tariff sheets to the Missouri Public Service Commission (Commission) on April 5, 2000, carrying an effective date of April 18, 2000. The tariff sheets were filed to reflect scheduled changes in MPS's Purchased Gas Adjustment (PGA) factors as the result of changes in the estimated cost of natural gas for the upcoming summer season. The summer season includes the months of April through October. Additionally, the Refund factor in the Southern System is modified to reflect the implementation of refunds received by the Company.

The effect of the change for the area served by the Southern System will decrease the firm PGA factor for the summer season to \$0.33481 per Ccf from a winter season firm PGA factor of \$0.36523 per Ccf.

The effect of the change for the area served by the Northern System will increase the firm PGA factor for the summer season to \$0.44655 per Ccf from a winter season firm PGA factor of \$0.41366 per Ccf.

For the Eastern System the Company requested a one-time waiver to allow its PGA remain at the current unscheduled winter season firm PGA factor of \$0.61489 per Ccf through the upcoming summer season to preclude significant under-collection of its gas costs.

The Staff of the Commission (Staff) filed a memorandum stating that the changes in MPS's PGA factors, except for the waiver request, were calculated in conformance with the Company's approved PGA Clause and recommends that the Commission approve the tariff sheets to become effective on April 18, 2000. Staff stated that MPS's PGA Clause allows for ten (10) business days notice for filings reflecting PGA changes. Staff recommends that the Commission approve the tariff sheets to become effective April 18, 2000, on an interim basis, subject to refund, pending final Commission decisions in MPS's Actual Cost Adjustment (ACA) Case Nos. GR-99-435 and GR-2000-520. Staff also recommends the Commission grant MPS a one-time waiver to maintain the unscheduled winter PGA factor through the upcoming summer season for its Eastern System.

The Commission has reviewed the tariff sheets, Company's waiver request, and Staff's recommendation, and finds that the tariff sheets, other than the waiver request, conform to its Commission-approved PGA Clause and are therefore reasonable. After considering Staff's recommendation, and for good cause shown pursuant to Section 393.140(11), RSMo 1994, the Commission is of the opinion that the proposed tariff sheets should be approved to become effective on and after the requested effective date of April 18, 2000, interim subject to refund.

#### IT IS THEREFORE ORDERED:

1. That the tariff sheets submitted on April 5, 2000 by Missouri Public Service of Kansas City, Missouri, be approved on an interim basis, subject to refund, to become effective on April 18, 2000. The tariff sheets approved are:

- 2. That MPS is granted a one-time waiver to maintain the unscheduled winter season PGA factor for its Eastern System through the upcoming summer season.
  - 3. That this order shall become effective on April 18, 2000.


