ORDER APPROVING TARIFFS

On February 29, 2000, Kansas City Power & Light Company (KCPL) filed revised tariff sheets to revise its Peak Load Curtailment Credit Rider and its Voluntary Load Reduction Rider. KCPL, at the request of the Commission Staff, withdrew that tariff filing and refiled it on March 29, 2000. KCPL requested expedited approval to allow more time to communicate with its customers before the curtailment season.

On April 12, 2000, Staff filed a pleading in which it recommended that the Commission approve KCPL's tariff filing in an expedited manner. Staff agreed that KCPL's request for expedited treatment established good cause for such treatment. Staff described the changes that KCPL proposed to its Peak Load Curtailment Credit Rider and its Voluntary Load Reduction Rider and recommended approval.

The Commission has reviewed KCPL proposed tariff sheets, the Staff recommendation and attached memorandum, and will approve the tariffs. The

Commission finds that good cause exists to approve the tariffs on less than thirty days' notice.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets filed March 29, 2000, by Kansas City Power & Light Company and assigned Tariff File No. 200000883, are hereby approved for service on or after April 21, 2000:
