

ORDER

On August 17, 1989, The Kansas Power and Light Company (KPL) filed applications to intervene in the captioned cases in which it is stated that KPL has a substantial interest because Trigen - Kansas City District Energy Corporation (Trigen) proposes to provide steam service as an alternative to natural gas service currently offered by KPL.

In the Commission's opinion the applications to intervene should be granted.

On August 24, 1989, the Commission's General Counsel requested a continuance of the hearings in these matters to allow the Commission Staff to provide its recommendation regarding rates. The request recites that Applicant, Trigen, has informed the Staff that its rate proposal will not be available until Monday, August 28, 1989, only one day before the presently set hearing. In the Commission's opinion the hearing should be continued to the next available hearing date.


It is, therefore,

ORDERED: 1. That the applications to intervene filed by The Kansas Power and Light Company on August 17, 1989, are hereby granted.

ORDERED: 2. That the hearings in these matters presently set for August 29, 1989, are hereby continued to commence at 10:00 a.m., on the 11th day of September, 1989, in the Commission's hearing room located on the fifth floor of the Truman State Office Building, Jefferson City, Missouri.

ORDERED: 3. That this Order shall become effective on the date hereof.
