### **ORDER DIRECTING FILING**

On September 1, 2000, K-Powernet, L.L.C. (K-Powernet), filed an application for a certificate of service authority to provide interexchange and nonswitched local telecommunications services within the state of Missouri. On September 12, 2000, the Commission issued a Notice of Applicants, directing interested parties to intervene by September 27, 2000.

On September 13, 2000, K-Powernet filed an amended application which was identical to the original application except for differences in the list of waivers requested. The Commission granted this request on October 2, 2000.

The Staff of the Commission (Staff) filed a Staff Recommendation on September 20, 2000. In this memorandum, Staff recommends that the Commission approve the waivers listed in the Notice of Applications. However, the Notice of Applications recited the waivers requested as of K-Powernet's original application, not the waivers listed in the company's amended application. The Commission requests that Staff clarify which waivers it recommends be approved.

#### **IT IS THEREFORE ORDERED:**

1. That the Staff of the Commission shall file a pleading clarifying which waivers it recommends for approval no later than October 9, 2000.

That this order shall become effective on October 10,
 2000.
