ORDER GRANTING STAFF'S REQUEST FOR EXTENSION OF REPORT FILING DATE

This case concerns the 1998-1999 Purchased Gas Adjustment and the Actual Cost Adjustment filings of Missouri Public Service, a division of UtiliCorp United Inc. No procedural schedule for consideration of these matters is currently in place because Staff has requested additional time to complete an investigation into UtiliCorp's gas purchasing practices. In a status report filed on June 6, 2001, Staff stated its intention to file its final recommendation on August 31, 2001. On June 11, the Commission acknowledged the filing of Staff's status report, but did not order Staff to file its final recommendation by any certain date.

On August 9, 2001, Staff filed a Request for Extension of Report Filing Date. Staff indicated that it has not yet completed its investigation and requested that it be allowed until September 30, 2001, to file its Recommendation. On August 16, UtiliCorp filed a response to Staff's request in which it indicated no objection to Staff's requested extension of time but expressed the desire that this matter soon progress to a conclusion.



The Commission will grant Staff's request for additional time. However, in order that this matter may be brought to a conclusion, the Commission will direct Staff to file its recommendation on or before September 30, 2001.

IT IS THEREFORE ORDERED:

- 1. That Staff's Request for Extension of Report Filing Date is granted.
- That the Staff shall file its Recommendation no later than September 30,
 2001.
 - 3. That this order shall become effective on August 30, 2001.
