**ORDER DIRECTING FILING**

On December 11, 2000, the parties herein unanimously moved the Commission to cancel the Prehearing Conference set for December 20, 2000, to relieve the parties of the obligation to file a joint Proposed Procedural Schedule by December 27, 2000, and to hold this case in abeyance pending final judicial resolution of certain similar issues presented by other cases. On December 15, 2001, the Commission granted the joint motion of the parties because the resolution of this case will turn on the resolution of issues now on review in other cases. The Commission placed this case in abeyance pending notification by the parties that it is appropriate to activate it and move it to resolution.

In order to ensure that resolution of this matter is not delayed unnecessarily, the Commission will direct the Staff of the Missouri Public Service Commission to advise it concerning the status of those cases whose review this case is awaiting. Further, the Staff shall update this status report at regular intervals hereafter.

**IT IS THEREFORE ORDERED:**

1. That the Staff of the Missouri Public Service Commission shall file a status report herein, on or before March 16, 2001, identifying by number each case whose resolution this case is awaiting and stating for

each such case the court or tribunal before which it is pending and the next significant event which is expected.

2. That the Staff of the Missouri Public Service Commission shall file a pleading updating the status report required in Ordered Paragraph No. 1, above, on or about the 16<sup>th</sup> day of every calendar month thereafter.

3. That this order shall become effective on March 8, 2001.


