ORDER

On November 17, 1986, L and K Sewer Systems, Inc. (Applicant) filed its application to sell and transfer its franchise, works, or system to M.P.B., Inc. (M.P.B.). M.P.B. and the Applicant are public utilities subject to the jurisdiction, supervision and control of the Commission. M.P.B.'s service area includes all of the area presently certificated to Applicant. Applicant's service area is in Franklin County, Missouri. Pursuant to Section 393.190, RSMo Supp. (1984), a sewer corporation must receive authorization from this Commission before such a transfer can occur.

In the event no proper party or governmental entity files an application to intervene or a motion to schedule a hearing in this matter, the Commission will allow the Applicant to submit its application by verified statements.

Applications to intervene should be filed with the Secretary of the Missouri Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102 and copies sent to Patrick C. Boos, M.P.B., Inc., 761 Pine Haven, Fenton, Missouri, 63026 Cars J. Detring, Attorney, West First & South Jefferson Streets, Farmington, Missouri 63640 and Alois J. Koller, L and K Sewer Systems, Inc., 1400 S. Highway 141, Fenton, Missouri 63026 on or before January 5, 1987.

The Secretary of the Commission shall send notice of this Order to the members of the General Assembly in the Franklin County service area of the Company

and to the publisher of each newspaper located in the Franklin County service area of the Company as listed in the Newspaper Directory of the current Official Manual of the State of Missouri. The Secretary of the Commission shall serve a copy of this Order upon the presiding Commissioner of the County Commission of Franklin County.

L and K Sewer Systems, Inc. should send notice of the proposed sale and transfer to the affected customers of the said Franklin County area by mail.

It is, therefore,

ORDERED: 1. That any interested person or entity shall file its application to intervene or motion to schedule a hearing in this matter on or before January 5, 1987.


ORDERED: 2. That the following notice shall be sent to the affected customers of L and K Sewer Systems, Inc. on or before December 15, 1986:

By application, L and K Sewer Systems, Inc. has requested the Missouri Public Service Commission to enter an order authorizing it to sell and transfer its franchise, sewer works or system to M.P.B., Inc.

Persons or entities desiring to formally participate in the case must file an application to intervene on or before January 5, 1987, with the Secretary of the Public Service Commission, P.O.
