ORDER APPROVING TARIFF SHEET

On November 17, 1986, L and K Sewer Systems, Inc., (applicant)  
filed its application to sell and transfer its franchise, works, or  
system to M.P.B., Inc. (M.P.B.).

On January 13, 1987, M.P.B. submitted a tariff sheet for the  
purpose of adopting the tariff filed by applicant and approved by the  
Commission.

The Commission is of the opinion the tariff sheet should be  
allowed to become effective for sewer service rendered by M.P.B. on and  
after January 19, 1987. The Commission is of the opinion that this  
tariff become effective on less than 30 days notice to allow M.P.B. to  
begin immediate operation under approved rates, rules and regulations.


