ORDER CANCELING CERTIFICATE

On March 9, 2000, the Staff of the Missouri Public Service Commission (Staff) filed with the Missouri Public Service Commission (Commission) its motion to open a "docket" [sic]¹ and cancel the certificate of service authority and accompanying tariff of BFI Communication, Inc. (BFI).

Staff stated that the Commission had granted BFI a certificate of service authority to provide intrastate interexchange telecommunications services in case number TA-97-364 on April 18, 1997². Staff stated that BFI did not file an annual report for 1998. Staff stated that BFI's 1999 annual report form was returned by the postal service as undeliverable. Staff stated that it contacted the Missouri Secretary of State's office and was informed that BFI was

administratively dissolved by the Missouri Secretary of State on August 18, 1997, due to its failure to file an annual report.

Staff stated that BFI has not filed a formal request to cancel its certificate. However, Staff believes that BFI has violated the terms of its certificate by its failure to keep the Commission informed of its current address and telephone number and its failure to file annual reports.

Section 392.210, RSMo³, states, in part: "Every telecommunications company shall file with the commission an annual report...covering the yearly period fixed by the commission." Section 392.390.1, RSMo, states, in part: "[A telecommunications company shall file] annual reports with the commission as required by the commission and in a form and at times prescribed by the commission." In addition, the terms of the certificate also require BFI to keep the Commission informed of its current address and telephone number.

Staff stated that the Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5, RSMo Supp. 1999, which states, in part: "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

In addition, Section 392.460, RSMo, states:

No telecommunications company authorized by the commission to provide or offer basic local or basic interexchange telecommunications service within the state of Missouri on

January 1, 1984, shall abandon such service until and unless it shall demonstrate, and the commission finds, after notice and hearing, that such abandonment will not deprive any customers of basic local or basic interexchange telecommunications service or access thereto and is not otherwise contrary to the public interest.

The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has requested a hearing in this case, the Commission may grant the relief requested based on the application.

The Commission has reviewed the application and the official file and finds that the Certificate of Service Authority granted to BFI in case number TA-97-364 shall be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of authority granted in case number TA-97-364 to BFI Communication, Inc. shall be canceled on April 17, 2000.
2. That this order shall become effective on April 17, 2000.

3. That this case may be closed on April 18, 2000.

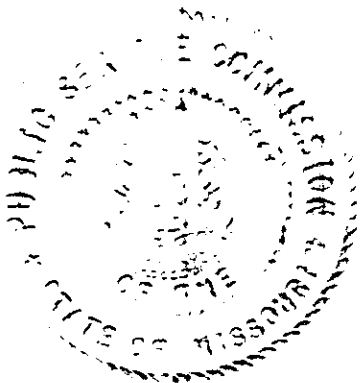
