

ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On April 28, 2000, Ellington Telephone Company d/b/a McCormack - Missouri (McCormack - Missouri) filed a Motion for Leave to File Annual Report Out of Time with the Commission requesting that its 1999 annual report, which was filed along with its motion, be accepted for filing. McCormack - Missouri stated that since April 15 fell on a Saturday this year, McCormack - Missouri's accountant assumed that the date for filing the annual report would be extended to the next business day, which was Monday, April 17. McCormack - Missouri requested that the Commission grant its Motion for Leave to File Annual Report Out of Time and accept its report for filing. McCormack - Missouri stated that no party should be prejudiced by the inadvertent delay. No objections to McCormack - Missouri's motion were received.

The Commission finds that good cause exists to permit filing of McCormack - Missouri's annual report out of time and the Commission will grant McCormack - Missouri's motion for leave.

IT IS THEREFORE ORDERED:

1. That Ellington Telephone Company d/b/a McCormack - Missouri's Motion for Leave to File Annual Report Out of Time filed April 28, 2000, is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived permitting the filing of Ellington Telephone Company d/b/a McCormack - Missouri's annual report on April 28, 2000.
2. That this order shall become effective on June 9, 2000.
3. That this case may be closed after June 12, 2000.
