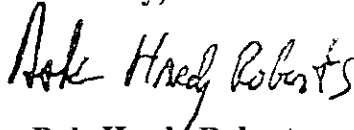

ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 3, 2000, Fidelity Long Distance, Inc. ("Fidelity"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. Fidelity stated that it was unable to file its report timely due to inadvertent difficulties meeting the filing time. No objections to Fidelity's motion were received.

The Commission finds that good cause exists to permit filing of Fidelity's annual report out of time, and the Commission will grant Fidelity's motion for leave to file its annual report out of time.

IT IS THEREFORE ORDERED:

1. That Fidelity Long Distance, Inc.'s May 3, 2000, motion requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of Fidelity Long Distance Inc.'s annual report on May 3, 2000, is approved.

2. That this order shall become effective on May 23, 2000.

3. That this case may be closed on May 24, 2000.
