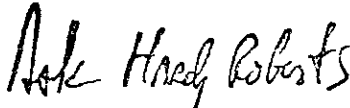

**ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME**

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 9, 2000, Matrix Telecom, Inc. ("Matrix"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. Matrix stated that it was unable to file its report timely due to inadvertent difficulties it described in meeting the filing time. Matrix also stated that it had conformed certain financial disclosures to Commission requirements. No objections to Matrix's motion were received.

The Commission finds that good cause exists to permit filing of Matrix's annual report out of time, and the Commission will grant Matrix's motion for leave to file its annual report out of time.

**IT IS THEREFORE ORDERED:**

1. That Matrix Telecom, Inc.'s June 9, 2000, motion requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of Matrix Telephone Company's annual report on June 9, 2000, is approved.
