ORDER GRANTING INTERVENTION

On October 29, 1999, the City of Rolla, Missouri (City), filed an application with the Commission seeking an order pursuant to Section 386.800, RSMo 1994, assigning exclusive service territories and determining fair and reasonable compensation. According to its application, the area concerned is a tract containing approximately 1,350 acres, recently annexed by the City, and presently provided electric service by Intercounty Electric Cooperative Association (Cooperative).

On December 2, 1999, an association of 16 persons applied through counsel to intervene herein, to-wit: Don Priest, Mary Ellen Irwin, Virginia Hays Priest, Marvin Konynenbelt, John E. Happel, Brooks R. Read, Diana L. Henry, Alva Branson, Danny Winstead, Sharlyn Winstead, Tom Green, Barbara Crowley, Nadine Jones, Calvin Jones, Deborah C. Volz, and Steven A. Volz (collectively the Southside Neighbors). These persons assert in their application that they are all persons residing within the area newly annexed by the City of Rolla and that they are all present electric customers of Intercounty Electric Cooperative Association. The Southside Neighbors also assert that they are directly interested in this proceeding; that their interest herein is different from that of the public generally; and that the public interest favors permitting them to intervene. No objections to this Application to Intervene were filed and the interval permitted by Commission rule to file such has elapsed.

The Commission has reviewed the application to intervene and finds that it is in substantial compliance with Commission rules regarding intervention and that the Southside Neighbors have an interest in this matter different from that of the general public. The Commission will grant the request for intervention.

IT IS THEREFORE ORDERED:

That the association known as the Southside Neighbors, Priest, Mary Ellen Irwin, Virginia Hays Priest, Marvin Konynenbelt, John E. Happel, Brooks R. Read, Diana L. Henry, Green, Barbara Crowley, Danny Winstead, Alva Branson, Tom Sharlyn Winstead, Nadine Jones, Calvin Jones, Deborah C. Volz, and Steven A. Volz, are granted intervention in this case in accordance with 4 CSR 240-2.075. The Commission's Records Department shall add their counsel to the service list in this case: Michael R. 2. That this order shall become effective on December 28, 1999.
