ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Axon Telecom, L.L.C. (Axon) applied to the Public Service Commission on August 18, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994¹. Axon asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Axon is a Kentucky corporation, with its principal office located at 450 Pryor Boulevard, Sturgis, Kentucky 42459.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on August 24, directing entities wishing to intervene to file their requests by September 8. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission,
776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked
permission to intervene or requested a hearing, the Commission may
grant the relief requested based on the verified application.

Axon filed a proposed tariff in conjunction with its application with an effective date of October 4, 1999. Axon's tariff describes the rates, rules, and regulations it intends to use, identifies Axon as a competitive company, and lists the waivers requested. Axon intends to provide interexchange telecommunications services including Private Line service and dark fiber facilities for lease by other telecom companies.

In its Memorandum filed on September 16, the Staff of the Commission stated that Axon's proposed services are similar to existing interexchange telecommunications offerings. Staff recommended that the Commission grant Axon a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff to become effective on October 4, 1999.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and Axon should be granted a certificate of service authority. The Commission finds that the services Axon proposes to offer are competitive and Axon should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Axon's proposed tariff details the services, equipment, and pricing offered, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on August 18 should be approved to become effective on October 4, 1999.

IT IS THEREFORE ORDERED:

- 1. That Axon Telecom, L.L.C. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That Axon Telecom, L.L.C. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
