ORDER APPROVING SECOND YEAR PHASE-IN TARIFFS

By its Order in this Case on April 1, 1987, this Commission  
authorized Kansas City Power and Light Company to file tariffs  
reflecting the phase-in plan authorized in that Order.

On April 6, 1989, Kansas City Power & Light Company  
submitted new tariffs sheets reflecting the increase for each of the  
remaining years of the phase-in plan. The second year phase-in  
increase is 2%.

The Commission is of the opinion the proposed second year phase-in tariffs submitted April 6, 1987, comply with its Order issued April 1, 1987 and said tariff sheets should be allowed to become effective for electric service rendered on or after May 5, 1987.

It is, therefore,

ORDERED: 1. That the following second year phase-in tariff sheets submitted April 6, 1987, by Kansas City Power & Light Company of Kansas City, Missouri, for the purpose of increasing rates for electric service provided to customers in its Missouri service area be, and they are, hereby approved and made effective for electric service rendered on and after May 5, 1987.


