

ORDER APPROVING TARIFF SHEETS

On September 3, 1987, a Stipulation and Agreement was filed with the Commission which had been executed by UtiliCorp United Inc., d/b/a Missouri Public Service (Company), the Staff of the Missouri Public Service Commission (Staff) and the Missouri Office of the Public Counsel (Public Counsel). This Stipulation involves a rate reduction to Missouri jurisdictional gross annual electric revenues of approximately \$5,400,000. The reduction reflects the impact of the Tax Reform Act of 1986 and also takes into account the Public Counsel's review of the Company's books and records as to the Company's revenue requirement.

On September 10, 1987 the Commission approved the Stipulation and Agreement that authorized the Company to file tariffs in compliance with the Order to be effective September 15, 1987. On September 11, 1987 the Company filed tariff sheets to comply with the Commission Order.

The Commission is of the opinion the tariffs submitted September 11, 1987, comply with its Order issued September 10, 1987 and said tariff sheets should be allowed to become effective for electric service rendered on and after September 15, 1987.

It is therefore,

ORDERED: 1. That the following tariff sheets submitted September 11, 1987, by UtiliCorp United Inc., d/b/a Missouri Public Service Company of Kansas City, Missouri, for the purpose of decreasing rates for electric service provided to customers in its Missouri service area be, and they are, hereby approved and made effective for electric service rendered on and after September 15, 1987.
