240-2.075, respectfully seeks to intervene in this proceeding and states:

1. Southwestern Bell is a Missouri corporation duly authorized to conduct business

in Missouri with its principal office at One Bell Center, St. Louis, Missouri 63101.

Southwestern Bell is a "local exchange telecommunications company" and a "public utility," and

is duly authorized to provide "telecommunications service" within the State of Missouri as each

of those phrases are defined in §386.020 RSMo (1994).¹

3. In this docket, Fidelity Communication Services, II, Inc. seeks a certificate of service authority to provide basic local telecommunications service in portions of the State of Missouri. Fidelity Communication also seeks classification as a competitive telecommunications company and the waiver of certain Commission rules and statutory provisions.

4. Southwestern Bell seeks to intervene in this proceeding because it has a direct interest in the Commission's decision on Fidelity Communication's Application. 5. Southwestern Bell's interests as a local exchange telecommunications service provider differ from those of the general public. No other party to this proceeding will adequately protect Southwestern Bell's interest.
