**SECOND JOINT ERRATA AND MOTION TO MODIFY ORDER APPROVING
INTERCONNECTION AGREEMENT**

Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC Missouri") and Charter FiberLink-Missouri, L.L.C. ("Charter") respectfully file this second joint errata to correct the "sequentially numbered" interconnection agreement ("ICA") between SBC Missouri and Charter presently on file with the Commission. The parties' ICA was approved by the Commission in its August 8, 2006 Order Approving Arbitrated Interconnection Agreement.¹ It has been discovered that the agreement's sequential numbering is erroneous in that no page marked as "page 395" appears. No contract language is affected by this inadvertent omission. For purposes of completeness, SBC Missouri and Charter submit herewith the attached Page 395 of said agreement marked "Intentionally Left Blank."

WHEREFORE, SBC Missouri and Charter respectfully request that the Commission accept this second errata to the parties' approved ICA, and further, that the Commission modify its August 8, 2005, Order Approving Arbitrated Interconnection Agreement to incorporate therein its approval of this second errata.

¹ On August 9, 2005, the Commission issued its Order Approving Errata prompted by the parties' having corrected the prior omission of the pricing appendix and certain page numbering deficiencies.
