## ORDER REVISING SCHEDULE OF PROCEEDINGS AND EXTENDING INTERLATA ACCESS CHARGE AND INTRALATA TOLL POOLS

On July 16, 1985, Staff filed its Motion for Order Revising Schedule of Proceedings and for Further Extension of Missouri InterLATA Access Charge and IntraLATA Toll Pools. Staff states that apparent discrepancies have been discovered between the data submitted by individual local exchange companies to the Staff and the corresponding data submitted to the administrator of the pools. Because of the number of companies involved and, for some companies, the relatively extensive nature of the discrepancies, Staff believes it is absolutely necessary that it issue and obtain responses to a follow-up round of data requests in order to attempt to clarify and reconcile the conflicting data. Staff believes that substantial clarification or reconciliation of these apparent discrepancies is necessary in order for it to reach conclusions regarding the status of the pools and to make informed recommendations regarding the future of the pools. Staff also believes that a further limited extension of the pools in order to permit such investigation is in the public interest. If the hearing dates proposed by Staff are adopted, it would appear that a minimum three-month further extension of the pools from December 31, 1985, until March 31, 1986, would be necessary.

On July 23, 1985, Southwestern Bell Telephone Company (Southwestern Bell or Bell) filed its Response to Staff's Motion. Bell proposed an alternate procedural schedule that would delay the conclusion of the hearings three (3) weeks beyond the existing schedule but provides Staff an additional seven (7) weeks to prepare its direct testimony.

The Commission has considered Staff's Motion and Bell's Response thereto and is of the opinion that Southwestern Bell's proposed schedule provides the most reasonable solution to the problems presented and should be adopted for use in these proceedings.

The Commission further believes that as Staff has suggested in its Motion, it will be necessary to extend the pools from December 31, 1985, until March 31, 1986.

It is, therefore,

ORDERED: 1. That the following revised procedural schedule is hereby adopted for use in these consolidated matters.

ORDERED: 2. That the InterLATA Access Charge and IntraLATA Toll Pools be, and they are, hereby extended through March 31, 1986, unless otherwise ordered by the Commission.
