**ORDER APPROVING TARIFF
AND CLOSING CASE**

This Commission granted a certificate to provide basic local telecommunications service in the state of Missouri to HJN Telecom, Inc. (HJN), on December 22, 1999. That order provided that HJN's certificate would become effective when HJN's tariff became effective. That order also required HJN to file a proposed tariff within 30 days of the approval by this Commission of an interconnection agreement between HJN and any of the incumbent local exchange carriers in whose service areas HJN may operate under the certificate granted in this order. The Commission approved such an interconnection agreement on September 29, 2000, in Case No. TO-2001-76.

HJN originally filed its proposed tariff on May 19, 2000, with an effective date of June 19, 2000. On May 22, and again on July 10, HJN extended the tariff's effective date by letter. On July 14, HJN filed a substitute proposed tariff. HJN again extended the tariff effective date by letter on August 4 and September 12, to October 10, 2000. HJN filed substitute tariff sheets on September 14, 2000, and again on September 25, 2000.

The Staff of the Missouri Public Service Commission filed its Memorandum and Recommendation on September 29, 2000. Therein, Staff recommends that HJN's tariff be approved. Staff states that HJN's tariff describes the services it will offer and the charges for those services, and also prescribes regulations regarding its provision of services. HJN will offer both residential and business services, as well as local operator and directory assistance, prepaid calling cards, access to 911/E911, Caller ID and Call Trace.

The Commission has considered the substitute tariff sheets filed by HJN and Staff's memorandum and recommendation. The Commission concludes that the substitute proposed tariff sheets are just and reasonable and should be approved to take effect on October 10, 2000.

IT IS THEREFORE ORDERED:

1. That the substitute proposed tariff sheets filed by HJN Telecom, Inc., on September 25, 2000, are approved for service rendered on and after October 10, 2000. The tariff sheets approved are:

2. That this order shall become effective on October 10, 2000.
3. That this case may be closed on October 11, 2000.
