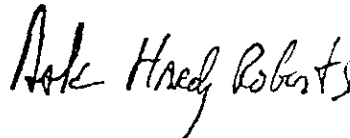

ORDER GRANTING APPLICATION

On June 28, 2000, TTI National, Inc. (TTI), an interexchange carrier authorized to do business in Missouri and other states, filed an application for approval to transfer customers and related waivers. TTI stated that it had acquired, at a public auction held pursuant to the United States Bankruptcy Code, the assets of Minimum Rate Pricing, Inc., Parcel Consultants, Inc., National Tele-Communications, Inc., and Discount Call Rating, Inc. (collectively, MRP). TTI stated that these assets included the customers of MRP. TTI proposes, upon Commission approval, to notify these customers that they will be receiving service from TTI (although they will be free to choose another carrier) at the same or better rates than they received from MRP. TTI also requested expedited treatment, asking for Commission action by July 21, 2000.

On July 12, 2000, the Staff of the Commission filed its recommendation. Staff recommends that the application be granted, and

an order issued with an effective date of July 21, 2000. Staff states that TTI has shown good cause for a waiver of 4 CSR 240-33.150. Staff also states that the transaction will not be detrimental to the public interest. Staff recommends that TTI be required to notify the Commission of the date certificates and tariffs should be withdrawn to coincide with the customer notifications.

The Commission has reviewed the application and the Staff Recommendation, and finds that the application should be granted. The Commission finds that good cause has been demonstrated for the waiver of 4 CSR-240-33.150.

IT IS THEREFORE ORDERED:

1. That the application for approval to transfer customers filed by TTI National, Inc. on June 28, 2000, is granted.
2. That 4 CSR 240-33.150 is waived for good cause shown.
3. That TTI National, Inc. shall notify each of the customers of Minimum Rate Pricing, Inc., Parcel Consultants, Inc., National Telecommunications, Inc., and Discount Call Rating, Inc. as described in the application.
4. That TTI National, Inc. shall notify the Commission of the date certificates and tariffs should be withdrawn to coincide with the customer notifications.

5. That this order shall become effective on July 21, 2000.
