ORDER APPROVING TARIFF

On March 31, 1994, Tele-Trend Communications, Inc. (Tele-Trend or Applicant) applied to the Missouri Public Service Commission (Commission) for a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri. On June 15, 1994, the Commission granted Tele-Trend's application and directed the company to file its tariff within thirty (30) days. Tele-Trend's certificate of authority becomes effective upon the approval of its tariff by the Commission.

Tele-Trend filed its proposed tariff on August 12, 1994, reflecting the rates, rules, and regulations it intends to use for providing services in Missouri. The tariff also reflects its status as a competitive tele-communications provider, and the statutory and regulatory requirements waived by the Commission pursuant to Section 392.420, RSMo Supp. 1993. Tele-Trend proposes to provide switched services, including "1+" long distance and 800 services; and dedicated services including voice grade access to long distance services. Tele-Trend filed substitute sheets on August 18 and August 31, 1994, to amend the proposed tariff.

On September 2, 1994, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum giving its recommendation. Staff stated

that it had reviewed the proposed tariff and substitute sheets and concluded that the tariff clearly and comprehensively describes the terms and conditions of the services to be offered, and that those services are within the scope of the certificate of authority conditionally granted. Staff concluded that the proposed tariff, as amended, is consistent with service offerings currently available from other interexchange carriers and approved by the Commission, is in compliance with Commission rules and regulations, and recommended that the tariff be approved, as amended, for service on and after September 15, 1994.

Having reviewed Tele-Trend's tariff and Staff's recommendation, the Commission finds that Tele-Trend's proposed tariff details the services, equipment, and pricing it proposes to offer, and that the proposed tariff is similar to those which have been approved for other Missouri certificated interexchange carriers providing similar services. The Commission further finds that the proposed tariff filed August 12, 1994, and amended on August 18 and 31, 1994, complies with the Commission's order and should be approved for service on and after September 15, 1994.

IT IS THEREFORE ORDERED:

1. That the tariff filed by Tele-Trend Communications, Inc. on August 12, 1994, is hereby approved, as amended, for service on and after September 15, 1994. The tariff approved is:

2. That this order shall become effective on the 15th day of September, 1994.
