Case No. TA-86-47

In the matter of the application of Eddie D. Robertson d/b/a Contact America for a certificate of public convenience and necessity to operate as a WATS Reseller.

Case No. TA-86-50

In the matter of the application of Communications Cable-Laying Company, Inc., d/b/a Dial U.S.A., for a certificate of public convenience and necessity to operate as a WATS Reseller.

ORDER

On May 22, 1985, the Commission issued its Order Consolidating Dockets and Establishing Schedule of Proceedings. Therein, the Commission consolidated all of the pending applications of the WATS resellers with Case No. TO-84-223,

Re: Investigation into WATS resale applications for certificates of public

convenience and necessity, for purposes of these proceedings. Case No. TO-84-223 was consolidated with Case Nos. TC-85-126 and TO-85-130 for purposes of hearing.

By Order issued August 6, 1985, and letter dated August 20, 1985, from Examiner DeFord, the Commission established the following procedural schedule:

Simultaneous Prepared Direct September 20, 1985 Testimony Filing Deadline (All Parties)

Early Prehearing Conference October 7, 1985

Simultaneous Prepared Rebuttal October 11, 1985
Testimony Filing Deadline (All Parties)

Prehearing Conference October 15, 1985 through

October 18, 1985, as necessary

Submission of Hearing Memorandum October 21, 1985

Simultaneous Prepared Surrebuttal October 23, 1985 Testimony Filing Deadline (All Parties)

Hearings October 28, 1985 through

November 1, 1985, November 4, 1985

through November 8, 1985 and November 12, 1985 through

November 15, 1985.

On September 12, 1985, Eddie D. Robertson, d/b/a Contact America (Contact America), filed its Application for certification as a wholesale and retail seller and lessor of interstate and intrastate long line, telephone and telecommunications services. Case No. TA-86-47 was established to consider this matter.

On September 16, 1985, Cable-Laying Company, Inc., d/b/a Dial U.S.A. (Dial U.S.A.), filed its application for certification as a wholesale and retail seller and lessor of interstate and intrastate long line, telephone and telecommunications services. Case No. TA-86-50 was established to consider this matter.

The Commission pursuant to 4 CSR 240-2.110(17) determines that Case

Nos. TA-86-47 and TA-86-50 should be joined with Case No. TO-84-223 for purposes of
these proceedings including hearing. Since the prepared direct testimony filing date

is September 20, 1985, the Commission recognizes that it will be necessary for Contact America and Dial U.S.A. to file their prepared direct testimony out of time.

Further, on September 18, 1985, Staff filed its Motion for Extension of Time for Filing Prepared Direct Testimony and Exhibits. Staff states that it will not be able to file its prepared direct testimony and exhibits in this matter in conformance with the existing deadline of September 20, 1985, and believes it will need six (6) additional days, until September 26, 1985, in order to submit its direct case filing.

The Commission is of the opinion that the six (6) day extension of time requested by Staff is reasonable and should be granted to all parties.

It is, therefore,

ORDERED: 1. That Case Nos. TA-86-47 and TA-86-50 be, and hereby are, joined with Case No. TO-84-223 for purposes of these proceedings.

ORDERED: 2. That the deadline for filing of prepared direct testimony is hereby extended from September 20, 1985 to September 26, 1985.

ORDERED: 3. That all further pleadings and testimony filed in these dockets shall be captioned: TO-84-223, et al.

ORDERED: 4. That this Order shall become effective on the date hereof.
