ORDER APPROVING TARIFF SHEETS

By its Order issued in this case on November 22, 1988, the Commission ordered Citizens Telephone Company of Higginsville, Missouri, to file new tariff sheets as approved in the Stipulation and Agreement. These revised tariffs implement a reduction to the Company's monthly local access rates by \$2.00 per line, a reduction of approximately \$80,000 on an annual basis.

In conformance with the Commission's Order, Citizens Telephone Company of Higginsville, Missouri, on November 23, 1988, submitted said tariff sheets with a proposed effective date of December 1, 1988.

The Commission is of the opinion that the proposed tariff sheets submitted on November 23, 1988, comply with its Order of November 22, 1988, and should be allowed to become effective on December 1, 1988.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted on November 23, 1988, by Citizens Telephone Company of Higginsville, Missouri, be, and they are, hereby approved to be effective on December 1, 1988.


