ORDER APPROVING TARIFF SHEETS

By its Order issued in this case on November 22, 1988, the Commission ordered Citizens Telephone Company of Wigginsville, Missouri, to file new tariff sheets as approved in the Stipulation and Agreement. These revised tariffs implement a reduction to the Company's monthly local access rates by \$2.00 per line, a reduction of approximately \$80,000 on an annual basis.
