ORDER APPROVING INTERIM RATES EFFECTIVE MARCH 1, 1995

On February 14, 1995, Union Electric Company (Company) of St. Louis, Missouri filed tariff sheets reflecting changes in the Purchased Gas Adjustment (PGA) factors for two of its Missouri natural gas service areas as the result of changes in the cost of natural gas and decreases in FERC Order 636 direct billed transition costs. Additionally, the Transportation Service charges for both areas will change.

The Company will experience a net decrease in annualized revenues of approximately \$2,481,900 in the area served by Panhandle Eastern Pipe Line Company. The Company will experience a net decrease in annualized revenues of approximately \$545,400 in the area served by Texas Eastern Transmission Corporation.

The Missouri Public Service Commission Staff (Staff) recommended the tariff sheets submitted in this filing be approved interim subject to refund pending a final Commission decision in Case No. GR-94-123, the Company's 1993-1994 Actual Cost Adjustment filing. Staff is also of the opinion that the filing complies with the Company's current PGA clause.

After considering Staff's recommendation and for good cause shown pursuant to Section 393.140(11) RSMo 1986, the Commission is of the opinion that the proposed tariff sheets should be approved to become effective on and after the requested effective date, March 1, 1995, interim subject to refund.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets filed February 14, 1995, by Union Electric Company of St. Louis, Missouri, for the purpose of reflecting changes in rates in two of its Missouri natural gas service areas be, and the same are, hereby authorized to become effective on and after March 1, 1995, interim subject to refund.
