**ORDER APPROVING TARIFFS**

By order of the Commission, issued February 17, 1995, a Stipulation and Agreement was approved authorizing Riverside Utility Company (Riverside) to serve an area previously served by Rankin Acres Water Company, Inc. Riverside was ordered to file tariffs in compliance with that order before commencing operation.

Tariffs were filed by Riverside on February 23, 1995, reflecting the first portion of the phased rates agreed to in the Stipulation and approved by the Commission. The tariffs filed by Riverside have an effective date of March 15, 1995. Subsequently a substitute sheet was filed with the Commission on March 7, 1995, to correct a typographical error.

On March 7, 1995, a recommendation was filed by the Staff of the Commission stating that, after review, the proposed tariffs were found to be in compliance with the Commission's order of February 17, 1995. In addition, the Staff pointed out that a second tariff filing will be made to become effective September 15, 1995, to complete the phase-in of rates.

The Commission has reviewed the proposed tariff filing and found it to be reasonable and in compliance with the Commission's order of February 17, 1995. The Commission will, therefore, approve this tariff filing for service on or after March 15, 1995.

In addition, the tariffs currently on file for service by Rankin Acres Water Company will be cancelled, and this docket will remain open for the subsequent and final filing by Riverside.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets, filed February 23, 1995, by Riverside Utility Company and corrected by the filing of one substitute tariff sheet on March 7, 1995, are approved for service on or after March 15, 1995:


