ORDER AND NOTICE AND PROCEDURAL SCHEDULE

On November 2, 1994, Union Electric Company (UE) and Laclede Electric Cooperative, Inc. (Laclede) (hereinafter collectively referred to as Applicants) filed a Joint Application requesting the Commission approve the Applicants' Territorial Agreement pursuant to §§394.312 and 416.041, RSMo (Supp. 1993) and further requesting the Commission allow such other actions as are necessary to carry out the agreement.

UE is an electrical corporation rendering electric utility service and is regulated by the Public Service Commission of Missouri. Laclede is a Chapter 394 cooperative corporation engaged in distribution of electric energy and service to its members within Camden County, Missouri. The Applicants have specifically designated the boundaries of the exclusive electric service area of each electric service supplier for service of new structures in portions of Miller and Camden Counties within their Territorial Agreement. There are no municipal electric supply systems operated within the area covered by the agreement but there exists several rural electric cooperatives in this area which are:

Southwest Electric Cooperative serving Camden, Benton, Hickory, Polk, Greene and Dallas Counties;

Gascosage Electric Cooperative serving Camden, Miller, Maries, Phelps and Pulaski Counties;

Co-Mo Electric Cooperative serving Benton, Morgan, Moniteau, Cooper and Cole Counties; and

Three Rivers Electric Cooperative service Morgan, Miller, Cole, Osage, Maries, Franklin and Gasconade Counties.

Upon reviewing the Application, the Commission is of the opinion that notice of this Application should be sent to interested parties, an intervention date set and a procedural schedule established as the Commission has one hundred twenty (120) days from November 2, 1994, pursuant to §394.312(3) to consider this Application.

The Commission determines that notice of this Application should be given by the Commission's Records Department by sending a copy of this order to the County Commission of Miller and Camden Counties, Missouri The Commission further determines that the Information Officer of the Commission should provide notice to the members of the General Assembly representing the Applicants' service areas and to the media which serves the Applicants' service areas which are covered by the Territorial Agreement.

Proper persons wishing to intervene shall have thirty (30) days from the date of this order to file an application to intervene with the Executive Secretary of the Commission, P.O. Box 360, Jefferson City, MO 65102, and a copy of the application to intervene shall be sent to the two attorneys on the Application, David C. Linton and Rodric A. Widger.

Lastly, the Commission will establish a procedural schedule as set out in more detail below.

IT IS THEREFORE ORDERED:

- 1. That the Records Department and the Information Officer of the Missouri Public Service Commission be directed hereby to send notice as set forth in this order.
- 2. That any interested party wishing to intervene in this case shall file such intervention as set forth in this order on or before December 19, 1994.
- 3. That the following procedural schedule for proceedings is adopted:

Direct testimony - Applicants	12/19/94 3:00 p.m.
Staff, OPC and intervenor rebuttal testimony	1/6/95 3:00 p.m.
Company surrebuttal	1/13/95 3:00 p.m.
Prehearing conference	1/26/95 10:00 a.m.

Evidentiary hearing will commence immediately following the prehearing conference

Prehearing conference and evidentiary hearing will be held in the Commission's hearing room on the 5th floor of the Harry S Truman State Office Building, 301 W. High St., Jefferson City, MO.
