Now comes L K Green, L R Creen, and R J Green, doing business as co-partners, and under the firm name of L K Greenland Sons, (not incorpora), and state that they are operating an electric light plant in Pleasant Hill, Cass County, Missouri, and also operating an electric light plant in Lees Tummitt, Jackson, County, Missouri, and it is their purpose to extend their service to other towns and villages, and individual consumers in said Cass County and Jackson County Missouri, and to build transmission line or lines necessary for the furnishing of said service. Said transmission line or lines are to sonsist of tall poles on which crods arms are placed at or near the tops, on said cross arms are placed at or near the tops, on said cross arms are placed large socket insulators, to support the transmission wires, the said wires being insulated in an approved manner, and to be at such a hight so as not to interfere in any meaner with the full and free use of the said highways by the public.

free use of the said highways by the public.

The said poles will be so placed as not to interfere in any manner with the use of the highways, being placed as close as possible to the fence of the line of such highways. That the said Company, will restore all parts of the highway where it is necessary to dig or excavate, so that there shall be no damage or injury to the same. The said Company, its successors or assigns agree to protect and save harmless the said County from any liability, claims or damage which may arise out of said erection or maintanence of the said transmission line or lines.

Wherefore your petetioners pray the Court to make am order herein permitting them to build said transmission lines including the setting of pales, stringing of wires, and doing such other things as may be necessary and ordinarialy incident to the construction and maintenance of said lines over the roads and highways of Cass County, Missouri.
